The Service Provider has represented (Solvix Skill development center) **SSDC** that it shallbe able to deploy sufficient resources, with the requisite qualification, experience and skill set, and other resources in accordance with prior consent of Solvix team to successfully conduct skilltraining programs in all sectors.

E. On the basis of the representation by the Service Provider as above, has agreed to avail the services offered by the Service Provider (SSDC) on the terms and conditions set out in this Agreement.

**NOW THEREFORE** this Agreement witnesseth and is hereby agreed to by and between the Parties as follows.

### I. DEFINITIONS

All capitalised terms in this Agreement not defined in this Section shall have the meanings set forth in the Sections or Schedules of this Agreement in which they are defined.

- 1.1 Intellectual Property Rights shall mean all intellectual property rights throughout the world, including copyrights, patents, mask works, trademarks, trade secrets, authors' rights, rights of attribution, and other proprietary rights which have been protected and recognised under the relevant laws.
- 1.2 **Representative** shall mean an employee, officer, director, or agent duly authorised by Party.
- 1.3 Term shall mean the initial term of the Agreement for three years
- 1.4 **Candidate** Candidate in this agreement will always refer to a graduate or post gradudate in life sciences, biotech, microbiology, biochemsitry, pharma, and allied health.
- **1.5** Force Majeure Event For the purpose of this agreement, Force Majeure shall include, but not limited to, natural calamities, earthquakes, epidemics, pandemics, quarantine, Acts of Government, civil commotion, war, riots and the like.

## II. SCOPE OF THIS AGREEMENT

- 2.1 During the term of this Agreement, the Service Provider shall have its instructors conduct the Training Program via eLearning platform or in its training facility, in accordance with the Training Calendar, targeted candidates as per scope and topics of training, modifying the structure and/or trainer upon obtaining the feedback from the trainees.
- 2.2 In addition to the above, the Service Provider shall provide J.B. the services related to and involved in
  - (i) Fulfill the branding guidelines of J.B. educational society.

(ii) the circulation of necessary program marketing and branding material post due approval of PARTY.

(iii) ensuring sending enrolment details of the candidates to PARTY on regular intervals

(iv) the necessary arrangements required conducting the training under the Training Program,

(v) providing the necessary training material as appropriate and as listed in program details

2.3 SSDC shall provide Service Provider the services related to and involved in conducting the assessment, including but not limited to

(i) Service Provider as eLeanring service partner under SSDC's "e-skilling" Scheme as per JBES GUIDELINES

(ii) Communicate the branding guidelines for "e-skilling" Scheme

2.4 Skilling Parnter NameJ.B.E.S., would launch the eLearning programs jointly.

2.5 skilling Partner Name SSDC will focus in Telangana for all streams /sector .

- 2.6 These programs would be totally job oriented and students would be prepared for the interviews, pre placement activities, online tests in addition to the job role.
- 2.7 Programs would be run and managed by BSSDC. Marketing would be done primarily by Skilling Parnter Name, however SSDC would also publicise the program through its portal and network.
- 2.8 Classes would be conducted using any platform to host conduct and conduct live sessions, and manage program end to end.
- III. TERM
  - 3.1 This Agreement shall be in effect for an initial term of Three years commencing from the Effective Date ("Initial Term") unless renewed by SSDC by issuing appropriate

communication to this effect within 60 DAYS to be reckoned from the date of coming this Agreement to an end.

#### **IV. TRAINING PROGRAM**

- 4..1 The number of Trainers, their names and other relevant details of those Trainers selected and designated by the Service Provider to conduct the Training Program, will be provided by the Service Provider to SSDC..
- 4.2 The Service Provider shall ensure that the reading material and/or any additional material for the Training Program does not infringe any third party Intellectual Property Rights or other proprietary rights and no royalty or other payment obligation arises. In the event of any such claim by any third Party, Service Provider shall be solely responsible to the extent consequential liability would arise.
- 4.3 The Training Program, including all related services, under this Agreement shall be performed by the employees of the Service Provider alone. Notwithstanding the forgoing, the Service Pr0.ovider shall not subcontract its obligations.
